CRFCRC AGREEMENT

I (we) agree that the club holding this show, match or obedience, field or hunting trial or test (collectively "Event") has the right to refuse this entry for cause which the club shall deem to be sufficient. In consideration of the acceptance of this entry and of the holding of the Event and of the opportunity to have the dog judged and/ or to win prize money, ribbons or trophies, I (we) agree to hold this club, its members, officers, committee members, sponsors, coordinators, directors and the owner or lessor of the premises, harmless from any claim of loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by my act or the act of my dog while in or upon the Event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss of this dog by disappearance, theft, death or otherwise, and from any claim for damage or injury to the dog, whether such loss, disappearance, theft, damage or injury, be caused or alleged to be caused by the negligence of the club, any of the aforementioned parties or any other person, or any other cause or causes.
