Owners whose dogs do not make the entry cut will be notified by October 30, 2020, and their entry fees will be returned. Each dog will be assigned a running number by random order of the draw.

### **COVID-19 Guidelines**

BY ENTERING THIS EVENT you acknowledge the current COVID-19 situation along with the applicable health rules and guidelines issued by the state of Maryland and Prince George's County. You acknowledge your choice to attend this event is voluntary and accept all responsibility resulting from attendance. You agree to take every precaution to keep yourself and others safe and will follow the direction of the Club with regard to social distancing, the use of masks, and agree to abide by any other modifications to traditional rules/behaviors the Club deems necessary to lessen the potential for exposure. The Club's scratch policy is modified to allow a refund for scratches due to the illness of the participant.

Masks are REQUIRED whenever you are unable to maintain a distance of 6 feet or more. Please bring your own mask and hand sanitizer.

If any of the following apply to you, please do not attend this event:

- You or someone that you live with is/are high risk
- You have tested positive or you have been around someone that has tested positive for COVID-19 in the last 14 days
- You have used commercial air travel in the last 14 days
- You have been showing any of the symptoms of COVID-19
- You have not been practicing good social distancing
- You have recently been or currently are sick
- You are not comfortable adhering to the following rules:
  - Social distancing from people not in your immediate family group or whom you have determined to be safe for you to interact with during the test day
  - Wearing a face mask whenever you are not able to social distance (6 feet or more) - e.g. loading/unloading equipment, helping with the tests. In the event a person(s) is not exercising good judgement regarding mask use, the Club will require that individual(s) to don their mask.
  - Wiping down equipment that has been handled by someone not in your immediate family group or whom you have determined to be safe for you to interact with during the test day
  - Bringing your own whistle, duck call, hand sanitizer, face mask, wipes, disinfectant and using them regularly

Due to the current COVID-19 restrictions, we are asking that only dog handlers attend/participate in this event. All potential handlers should evaluate their individual risk factors related to participating in this FCRSA event before entering. Entering and running a dog in this event should not take priority over individual health. The Capital Region Flat-Coated Retriever Club intends to strictly adhere to and enforce social distancing guidelines provided by both the AKC and Prince George's County, Maryland as outlined below:
