In late 2002-early 2002, two fundamental changes occurred. The secretarial job was split into two positions and a two year term limit was adopted for officers and board members. Names highlighted in light green would be termed out for that position in the shaded term, although the board has discretion to extend the term by a majority vote if there are difficulties filling the position. Single year terms used to offset some positions were not counted toward the term limits but previous service could be. In 2003, the club voted to eliminate the board position vacated when Damw was electriselent. This was done to make an even number of officers and board members (when that the president) so that the president would resume the role of tie-breaker for votes. In 2004, the President created a ByLaws & Constitution export; also, one board member moved to an officer's position in mid-term and the board position was filled by appointment of the standing board. In 2015, we realized that the term limits were never actually implemented by Board or Membership vote and decided that, given our Club's size, the limits were impractical anyway:
